

Masters Exhibition Report – 2019

The Masters Indoor Exhibition event was held at the Ocean Breeze Sports Complex in Staten Island, NY with 12 participants competing in the 60m dash. The age range of the participants was 60 and over. The event was very successful and well received by the spectators and participants. Professional photos were taken of each participant by volunteer videographer Clinton Aurelien.



The Masters Outdoor Exhibition event was held at the USATF National Championship meet in Des Moines, IA. Even with the event being held directly after the Masters Outdoor Championship meet and the NCCWMA meet in Toronto, we managed to get 7 female and 5 male athletes ages 50 and over to compete in the 200m dash. The spectators were wowed. The announcing was fantastic. The live stream coverage was amazing. Several correspondences from the athletes were received emphasizing their enthusiasm and appreciation for this event. Many letters and IMs of inquiry about the MEE 2020 events have already been received.

An approval was given by Sandy Triolo, the MTF Communications Chair, for the addition of a new MEE webpage as part of the official MTF website. We hope to have the webpage ready for the 2020 Indoor season. We are anticipating a high level of interest at the 2020 Outdoor event, since it will be held during the USA Olympic trials.
