MTF Personnel Changes – Jerry Bookin-Weiner

- Marty Johnson taking over for Bill Murray as Games Committee Chair
- Rachel Guest taking over for Amanda Scotti as Secretary

Nominating Subcommittee Report – Jim Pearce

- Individuals already identified and accepted as candidates are: Robert Thomas (Chair), Colleen Barney (Vice Chair), Rachel Guest (Secretary), Mike Travers (Treasurer)
- Notice sent out to athletes to advice accepting nominations. Responses include:
 - Chris Rinaldi interested in Vice Chair. Was advised will need to be nominated by the floor
 - Judge Peter Wirs currently no real involvement with MTF. Did not specify a position interested in. Encouraging to get involved in committees, other roles to gain knowledge and experience with MTF
- After all nominations are collected and report by committee, each candidate will have up to 5 minutes to speak. Any unopposed candidates can be elected immediately by acclamation.
- Opposed candidates will be voted on next day by 39 active athletes and other delegates at the Annual Meeting. Email will be sent in the morning and 1 hour will be given to place votes.

A – Jerry Bookin-Weiner advised will post form in November for individuals to fill out in advance. Can also collect when at the annual meeting before the Committee convenes. Rachel and Colleen will work on forms to ensure eligible.

Reimbursements - Mike Travers

- Jerry Bookin-Weiner, Robert Thomas, Chris Pasko, and Mike working on getting all payments sent. All have been submitted and waiting on processing by USATF Finance
- Everyone has been timely at submitting expenses
- Mike has been encouraged to bring this issue to Mike Conley and Rose Monday (the candidates for USATF President) so they are aware and can work on how will handle if elected.
- Zack Raubuck leaving set everything back due to his contacts and business knowledge and ability to move things along

A – Jerry Bookin-Weiner: was advised it is a cashflow issue

A – Chris Pasko: security for Peru was \$2 mill and did not help the cashflow Issues. Also adding in the Olympics, it has not helped.

• If putting on a region meet and have people that will get reimbursed for travel, need to send into to Jerry or successor to get a TA in advance; otherwise they cannot be paid.

2025 Outdoor Championships Update - Robert Thomas

- Site visit (Sandy Pashkin and Marty Johnson) scheduled for Huntsville, AL in November.
 - o Have resurfaced track and currently working on throws areas

- Spire Institute in Ohio has not responded to requests to see if interested in hosting
- 2027 bids: Ames, IA for outdoor and Gainesville for Indoor

Operating Procedures Proposed Changes - Colleen Barney

- Current procedures needed general cleanup
- Actively engaged athletes (active athletes) verbiage not in line with USATF.
 39 people should be people that are knowledgeable and actively competing in the sport
- Officers and duties chair to make the decision and the executive committee approves.
 - o Team Manager
 - o Regional coordinators
- Add to Executive Committee
 - o Racewalk Chair
 - Anti-Doping Chair
- All nominees up for vote
 - o Officers get 5 minutes to speak with 5 minutes for questions
 - Active Athlete Representative candidates get 1 minute with 1 minute for questions
- If vacancy occurs in any officer position
 - o Chair, vice chair to assume position
 - All others the chair selects successor and the executive committee approves
- Sub Committees
 - Positions currently end at the end of the Annual Meeting. Proposed to extend until the end of indoor nationals the next year (approximately three months)

Rule Change Proposals – Sandy Pashkin

- Woman's Decathlon for records
 - o Only in the men's order
- Steeple Barrier
 - New height to be included with 36 and 33
- New hurdle specifications go into effect January 1, 2026 for spacing W70+ and M80+
- Hammer throw handle specifications to bring in line with WMA
- Doping violations proposal that those who have a doping violation be deemed ineligible to set records
- Penalty lane road racewalk to be WMA compliant

Anti-Doping Update - Cheryl Bellaire

- Continue to put info out in NMN
- Work with WMA/USATF MTF

- Webinar w/USADA
- Athletes who are sanctioned and continue to compete, call USADA hotline
 - o Had 2 positive tests in Sacramento, 1 in Chicago and 1 refusal

Indoor Nationals 2025 Update – Robert Thomas, Colleen Barney, Jerry Bookin-Weiner

- Website for nationals should be up next week
- Can start registering once the new membership year starts on November 1
- Will continue to be through Simply Register
- Hotels are cheaper for nationals than worlds
- 140 applied for officials and need to confirm since same weekend as the open national championships

- Marty Johnson confirmed officials have been selected for WMA
